Application for Special Occasion Permit Video Production Amendment

1. How to Apply

- A. Discuss your plans with the area park superintendent or wildlife management area district manager at least 30 days in advance.
- B. Review and complete both the Application for Special Occasion Permit and this Amendment and forward both documents to the area state park superintendent or the wildlife area manager regional district manager or to the Nebraska Game and Parks Commission at the above address at least 30 days prior to the scheduled event.

2. Terms and Conditions

1. A special occasion permit must be completed, in advance and approved by the Nebraska Game and Parks Commission (Commission).
2. Commercial filming, videography, recording, photography, livestreaming, and commercial broadcast are referred to as "production."
3. Commercial production includes activities that include models, sets and props for the purpose of promoting goods, services or brands. Non-professional nature photography, family, wedding and senior photography, and recreational photography are not subject to these terms.
4. No public visitors will be displaced for production, arranging shots, etc.
5. No activity will disrupt other park or wildlife management area guests, including noise, obscenity, profanity, or public indecency.
6. Signs may be posted, per the park superintendent's or wildlife management area district manager's approval, to make the public aware that production is taking place.
7. No changes to park facilities or other temporary adjustments are permitted without prior approval of the park superintendent or wildlife management area district manager.
8. Any commercial production within Commission state historical parks or museums or display areas requires the park superintendent's prior approval to protect the integrity of historical artifacts.
9. Any appearance release is the sole responsibility of the production company.
10. Commission logos or signs may not be filmed, represented or be visible in the production without permission.
11. Use of Commission properties for the purpose of producing commercial advertising for goods or services shall not imply sanction or endorsement by the Commission.
12. All images, video and recordings must comply with state and federal regulations.
13. Vehicle and boat operators must follow state regulations.
14. Arbor Lodge State Historical Park and Ashfall Fossil Beds are not included in these guidelines. Parks management should be contacted directly.
15. All special requests must be pre-approved by the park superintendent or the or wildlife management area district manager.
16. A valid Nebraska State Park entry permit is required for all vehicles entering any Nebraska park, state recreation area or historical park, except those exempted by law. Other fees may apply.
