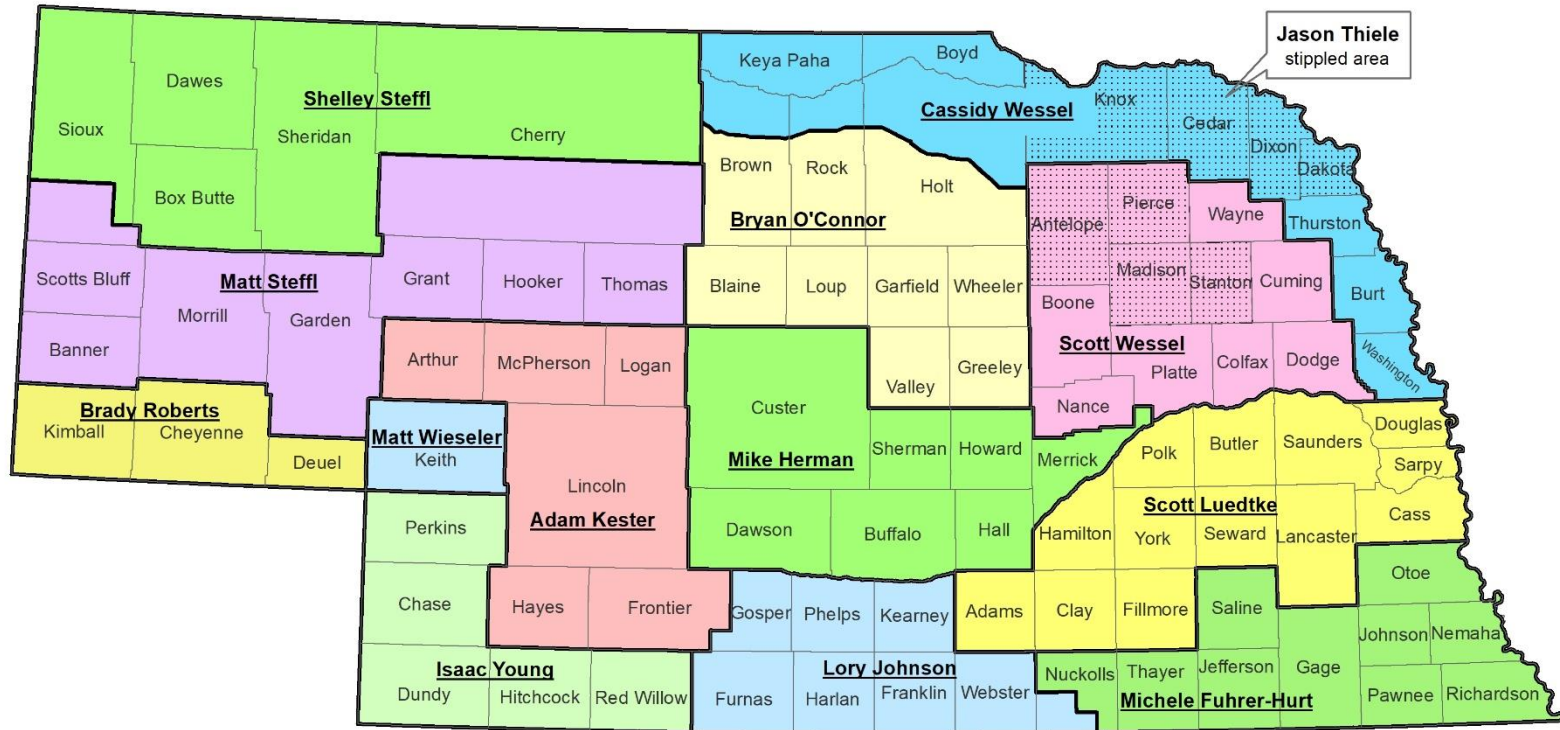


Nebraska Game and Parks Commission's Habitat Partners Section Regional Boundaries
